From initial intake through permanent supportive housing to independence and self-sufficiency, RCAA's Family Services Division is continually challenging itself to develop and refine strategies that assist families to move from crisis into stability and beyond. RCAA provides continued and targeted support for the development of healthy, stable, thriving families along all points of the continuum of care. RCAA is committed to identifying any gaps and providing services and support where necessary. RCAA is an essential member of the emergency network responsible for information and referral around specific issues and resources in Humboldt County.

Stormwater - RCAA helps local agencies and organizations meet and exceed state stormwater regulations.
