The following services are provided by the program: Health & Safety Testing and Repairs; Energy Efficiency & Weatherization; Lead Based Paint Hazard Reduction & Inspection Services; Energy, Environmental & Telecommunications Education and Energy Assistance.

The Family Services program provides diverse and comprehensive services to homeless, disabled and low-income clients. RCAA offers education, coordination and encouragement in the client's work through the barriers to self-sufficiency. From initial intake through permanent supportive housing to independence and self-sufficiency, RCAA's Family Services Division is continually challenging itself to develop and refine strategies that assist families to move from crisis into stability and beyond. RCAA provides continued and targeted support for the development of healthy, stable, thriving families along all points of the continuum of care. RCAA is committed to identifying any gaps and providing services and support where necessary. RCAA is an essential member of the emergency network responsible for information and referral around specific issues and resources in Humboldt County.
