RCAA provides continued and targeted support for the development of healthy, stable, thriving families along all points of the continuum of care. RCAA is committed to identifying any gaps and providing services and support where necessary. RCAA is an essential member of the emergency network responsible for information and referral around specific issues and resources in Humboldt County.
